1. All persons have an electronic mailbox

How to proceed if a certain electronic submission, document or form need to be signed by several persons in the electronic mailbox, we will show below on the example of electronic submission via the General Submission service addressed to the test electronic mailbox of the National Agency for Network and Electronic Services.

Persons, who have a foreign means of electronic identification, as electronic mailbox is automatically created for them at the first login, can also use the procedure below. You can find more information in [User guide for the use of the electronic mailbox](#).

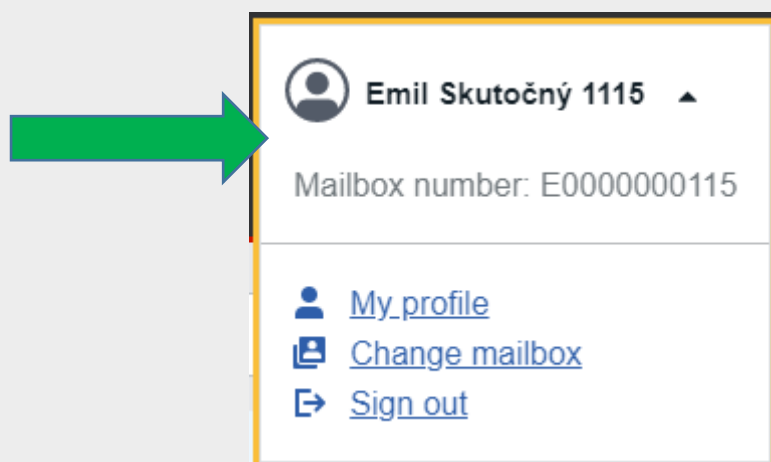
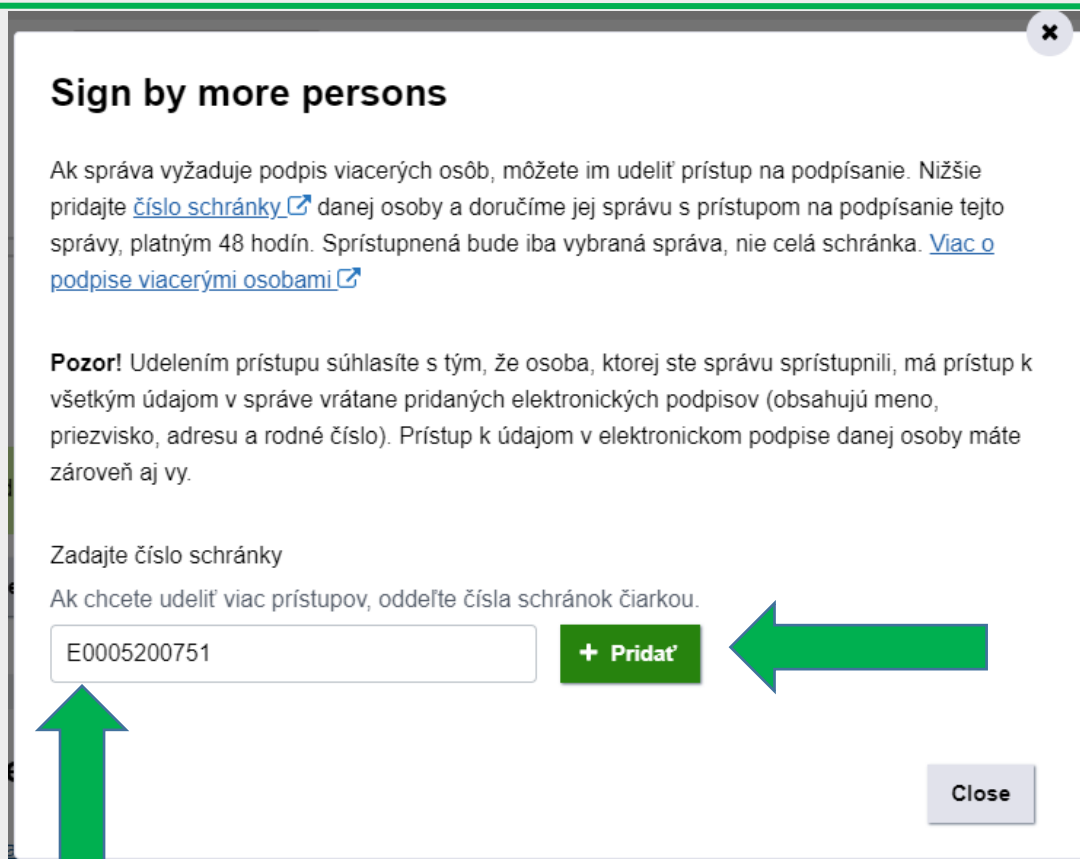


Figure 1 - Electronic mailbox number

Step 1 - In person, by phone, via SMS, e-mail, etc. find out the electronic mailbox number of the persons who need to sign the application. The mailbox number is situated in your electronic mailbox in the top right corner in mini profile after clicking on the arrow (Figure 1).

Step 2 - Log in to the electronic mailbox on the portal <https://www.slovensko.sk/en/title>.

Step 5 - If you really want to grant access for signing, go to “Confirm”. Enter the 6-digit security personal code (BOK). The signing access is granted.

Step 6 - Click on “Save message” (it will be shown in Drafts).

Step 7 - The person to whom you have granted access will receive a message in the electronic mailbox “Udelenie prístupu na podpísanie” (means Granting access for signing) containing a hyperlink (Figure 4). The validity of the granted access is 48 hours.

Step 8 - Click on the hyperlink and the limited submission will open - the submission can be downloaded via the "..." (three dots) menu. The submission text cannot be changed. The signature is added via "Sign".

Step 9 - The D.Signer XAdES.NET application displays that the Document is not signed. It is necessary to click on "Sign", then select the certificate, click "OK" and enter the KEP PIN. The document will be signed successfully.

Step 10 - After signing, press "Dokončiť" (means Finish), which automatically cancels access to the message. Subsequently, a notification will be displayed whether the person with the granted access has added a signature, or whether he has downloaded the message / document (Figure 5). When you click the hyperlink again, you will only see the information "You do not have permission to view this message."

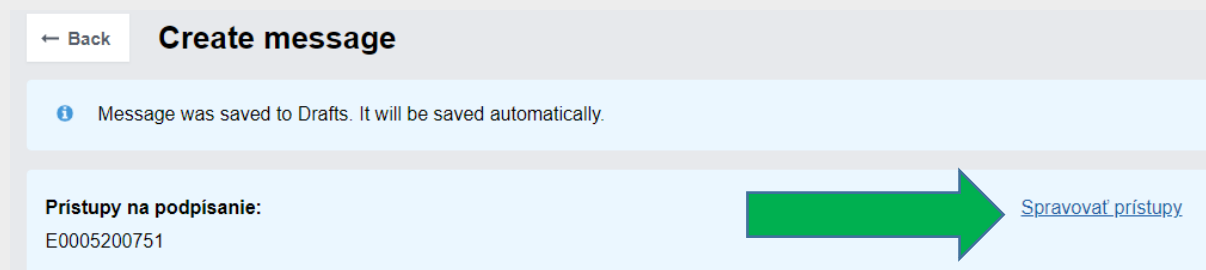


Figure 6 – Manage accesses

Step 11 - Autor of submission will find the message in the "Drafts". The electronic mailbox numbers that have been granted signing access are displayed above the submission. Through "Spravovať prístupy" (means Manage accesses) (Figure 6) he has the option to cancel the granted access via "Odobrať prístup" (means Remove access) (eg if the author of the submission entered an incorrect electronic mailbox number, etc.), but only on condition that the person has not signed yet and did not click "Finish".

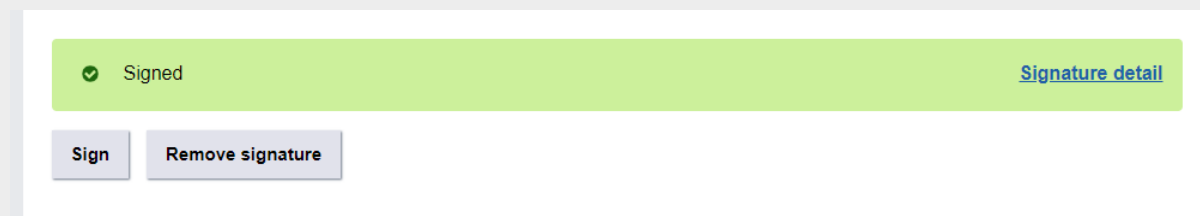


Figure 7 – Signature detail

Step 12 - After adding the signature by the authorized person, a green box with the information "Signed" will appear in the submission. You can see the signature information via "Signature detail" (Figure 7).

After clicking on "Signature detail" (Figure 7) or "Verify signatures", the result "Informative signatures verify result" will be displayed (Figure 8), where you can view and check the signatures, what document who signed, whether it is a valid signature and when the timestamp was added.

Step 13- If all interested parties have signed the application, you can move to "Send".

2. Some persons do not have an electronic mailbox

The procedure below can be used in particular if you need to secure the signing of a submission or document by a person who does not have electronic mailbox because does not have an official or alternative authenticator or electronic identification device

from another EU country, or electronic mailbox is set up, however, for any other reason, he cannot add signature directly in the mailbox.

Step 1 - Download the signed document from the electronic mailbox via the menu "..."

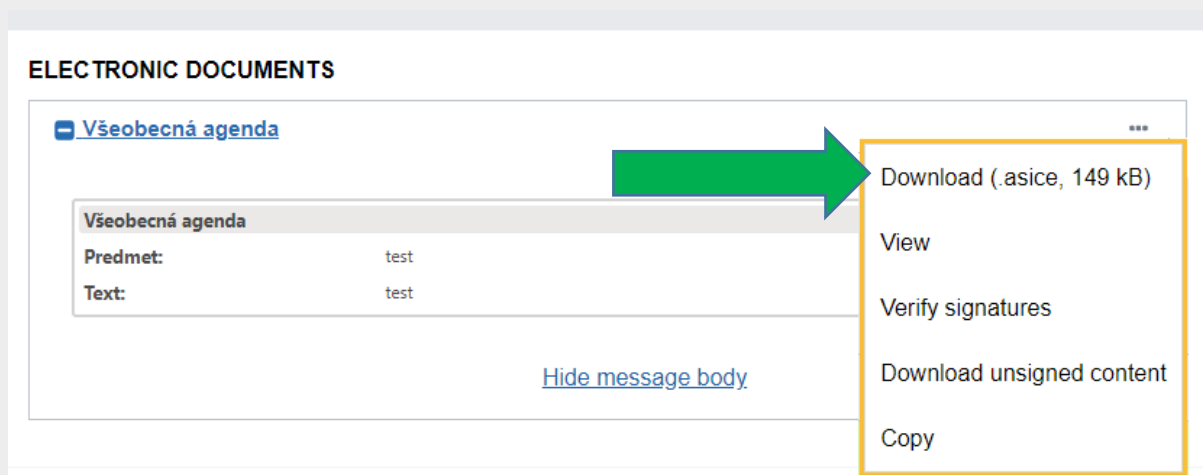


Figure 9 - Download a signed document

(three dots) and the option "Download (.asice, ...)" (Figure 9).

Note:

You can also send an unsigned .xml file for signature to another person, but in this case it is necessary for this person to use an application that creates the XMLDataContainer format from XML data according to Appendix no. 7 Decrees on standards for information technologies of public administration. Otherwise, such a submission may not be accepted. The XMLDataContainer format does not allow you to create an e-mailbox directly, but is created before the signature is created.

Step 2 - Then save the message in Drafts folder via the "Save message" button (Figure 10).

Step 3 - Give the downloaded file (e.g. by e-mail, USB, etc.) to the person concerned for signing. The person must have an application that supports the addition of qualified electronic signatures in the ASiC-E XAdES Baseline profile format to existing signatures (according to the Commission Implementing Decision (EU) [2015/1506](#)).

Step 4 - After successfully signing, the person should give/send the file with their added signature back in ".asice" or ".sce" format.

Step 5 - In the "Drafts" folder, find the concerned message and select "Edit message" (Figure 11).

Step 6 - Via the menu "...", select the option "Upload filled XML form" in the line "Electronic document" (Figure 12) and add the submitted signed document.

If the document intended only as an attachment to the submission, upload the document only in the "Attachments" section (Figure 13).

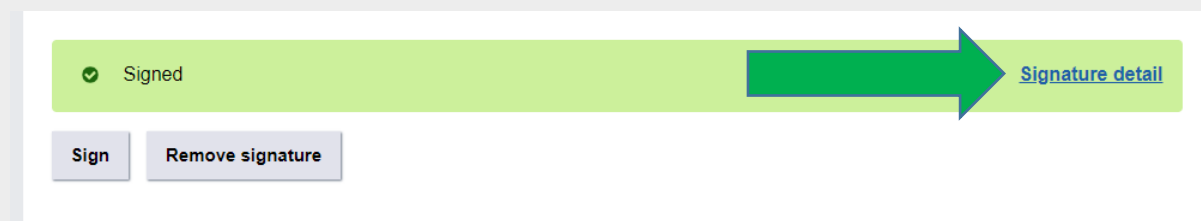


Figure 14 – Signature detail

Step 7 - If the document is successfully loaded, the information "Signed" will be displayed in a green box and also the option "Signature detail" (Fig. 14). In the signature detail, check whether the document is actually validly signed by the person (Figure 6, 7, 8). If the document load ends with an error, it may be because, for example, the file was not signed by a supported signature format.

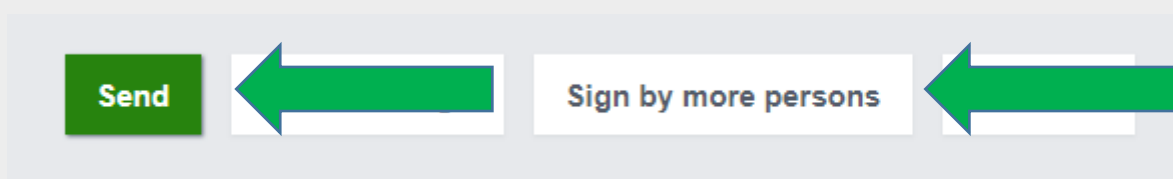


Figure 15 – "Sign by more persons" and "Send" buttons

Step 8 - If necessary, you can move the signed document for signature via the "Sign by more persons" button, send it in the same way as below to other persons who do not have electronic mailbox or click "Send" directly if the submission contains all necessary signatures (Figure 15).
